**SECTION 4: FIRST AID MEASURES**
**4.1 Description of first aid measures:**

**By skin contact:**

This product is not classified as hazardous when in contact with the skin. **SECTION 5: FIREFIGHTING MEASURES**
**5.1 Extinguishing media:**
